III. Approval of Minutes

IV. Financial Update

Payment Request – Mr. Norris reported that the Executive Committee approved the April payment requests. The April payments were comprised of the following: a total of \$1,058,211.32 with \$981,495.08 from the O&M Fund, \$39,758.43 from the General Fund, and \$36,957.81 for the May Estimated Payroll.

The May payments were comprised of the following: a total of \$906,841.56 with \$865,898.42 from the O&M Fund, \$3,380.76 from the General Fund, and \$37,562.38 for the June Estimated Payroll.

The June payments were comprised of the following: a total of \$1,173,802.86 with \$1,117,459.28 from the O&M Fund, and \$56,343.58 for the July Estimated Payroll.

Treasurer’s Report – Mr. Norris reviewed the Treasurer’s Report for the month of May with revenues and expenditures that tie directly to the budget line items and indicate what has been spent in the fiscal year to date along with the percent remaining. Mr. Van Vooren reminded Members that the trustee agreement ended May 1, 2015 and the Agency bonds have been paid in full.

Alternate Director Krumstok made a motion to accept the Treasurer’s Report. Director Thill seconded the motion. The motion was approved. Ayes 18, Nays 0

V. Executive Session

Litigation – Upon a motion by Director Norris, seconded by Director Darch, the Board of Directors entered into executive session, after a unanimous roll call vote, at 6:04 p.m., to discuss litigation under Section 2 (c)(11), review of historical Executive Session Minutes to be released 2(c)(21), and Preliminary GTS RFP Update - Section 2(c)(5 and 6) of the of the Open Meetings Act.

VI. New Business

Matters Arising Out of Executive Session –

Glenview Transfer Station. Director Norris made a motion to concur in the recommendations of the Executive Committee, decline the offers to purchase the Transfer Station, decline the alternatives to an Operating Contract model, and to award the operating contract for the Glenview Transfer Station to Groot Industries based upon their final and best price detailed through the RFP. Alternate Director Jekot seconded the motion. Ayes 19, Nays 0

Executive Director Performance and Contract. Director Norris made a motion to concur in the recommendation of the Executive Committee and approve the Executive Director a contract extension through 2018. Director Hoefert seconded the motion. Ayes 19, Nays 0

Second Half FY2015 Recycling Incentive Program – Executive Director Van Vooren reviewed the second half payment for member communities that are participating in the Recycling Incentive Program. He added that there is no take back refund by the Agency.

Special Program Update – January-April 2015 – Executive Director Van Vooren presented the report on school programs at varying levels throughout the region. Some schools are at the level of basic core recycling, while others are entering into food scrap and zero waste efforts.

FY2015 Commercial Waste Program – Executive Director Van Vooren highlighted the increased waste volumes at the GTS from small vendors.

July Report – Executive Director Van Vooren highlighted that 1) the annual fiscal audit with Miller Cooper has begun; 2) May 1st was the last bond payment; 3) continued efforts with electronics recycling vendor, 4) HB 1455 regarding Illinois' electronics recycling law is still waiting for the Governor's signature and that he would circulate a letter for communities to send along to Springfield.

Mr. Van Vooren stated that SWANCC published notice of the Public Hearing for the FY2017 Budget in the Chicago Tribune on February 8, 2016. The Final FY2017 Budget has been recommended by the Executive Committee and shows a decrease in the tipping fee of \$3.10 per ton from the September

2015 revised FY2016 Budget. This is primarily due to the implementation of the new GTS operating contract which began September 1, 2016. Projected waste delivery for Members is also down slightly to a total of 231,172 tons. The FY2017 budget anticipates a total tipping rate of \$46.06 per ton, the lowest rates since 1995. Chairman Van Dusen asked if there was any public comment on the budget.

Hearing no public comments, Director Norris made a motion close the Public Hearing and put the FY2017 Budget on file for public inspection. Director Tisdahl seconded the motion. The motion was unanimously approved. Public Hearing was closed at 6:11 pm.

VI. New Business

Legislative Update – Mr. Van Vooren provided an update on pending bills before the Illinois House and Senate that have some impact on SWANCC’s mission. He specifically pointed out three bills.

The first, House Bill 4202, which creates the plastic bag and film recycling act which prohibits manufacturers from selling bags without being registered and establishing a plan to recycle them. This bill denies Home Rule powers. The Executive Committee recommends supporting this bill.

The second bill, House Bill 6029, amends the Solid Waste Planning Act to provide that county solid waste management plans include the study of food scrap composting in their five year updates. The Executive Committee recommends either opposing the bill or recommending that SWANCC be exempted from being part of the county’s planning.

The third bill, Senate Bill 2202, amends the Illinois Municipal Code to provide that construction and demolition (C&D) material is not garbage or refuse, and that municipalities are excluded from entering into C&D commercial franchises. The Executive Committee recommends SWANCC be neutral on this issue. Although it does restrict municipalities’ ability to franchise for collection, this is a small issue and this bill would not lead to inefficient collection.

VIII. Executive Director’s Report

Mr. Van Vooren presented the status report to the Board and pointed out that the Contract with COM2 has been renewed by the Executive Committee to continue to provide E-Waste recycling to residents.

We hope to have a bill that amends the E-Waste Law to accomplish these items this session.
